Competency	Method of Assessment

Perspective	Method of Assessment
1. Establish broad and multiple perspectives of the individual in relationship to the larger society and world in which he or she lives, and help the student to understand the responsibilities of living in a culturally- and ethically-diversified world;	Students write essays based on texts examining issues of individual, cultural, and global concern.
2. Stimulate a capacity to discuss and reflect upon individual, political, economic, and social aspects of life to understand ways to be a responsible member of society;	Class discussions/examinations/papers require students to address texts that reflect political/economic/social issues after Swift.
3. Recognize the importance of maintaining health and wellness;	
4. Develop a capacity to use knowledge of how technology and science affect lives;	
5. Develop personal values for ethical behavior;	Students are required to discuss or respond in writing to ethical issues raised in texts.
6. Develop the ability to make aesthetic judgments;	Students demonstrate their ability to make judgments about literary texts through class discussion or written responses.
7. Use logical reasoning in problem solving;	Students write essays requiring the use of logical reasoning to arrive at a conclusion.
8. Integrate knowledge and understanding of the interrelationships of the scholarly disciplines	Examinations, essays, and class discussions require students to integrate knowledge from related fields of study.

Exemplary Educational Objective	Method of Assessment
1. Demonstrate awareness of the scope and variety of works in the arts and humanities.	Students must read and respond to British literary works of various genres after Swift.
2. Understand those works as expressions of individual and human values within a historical and social context.	In essays and examinations, students must demonstrate an understanding of the historic and social contexts of assigned works
3. Respond critically to works in the arts and humanities.	Students write critical analyses of assigned literary works.
4. Engage in the creative process or interpretive performance and comprehend the physical and intellectual demands required of the author or visual or performing artist.	Students receive biographical information about authors and discuss the intellectual demands made on the individual by the genre.
5. Articulate an informed personal reaction to works in the arts and humanities.	Students are required to discuss and write essays and examination questions in response to assigned works.
6. Develop an appreciation for the aesthetic principles that guide or govern the humanities and arts.	Students write essays, answer examination questions, and engage in class discussion to demonstrate their understanding of aesthetic principles revealed in the course.
7. Demonstrate knowledge of the influence of literature, philosophy, and/or the arts on intercultural experiences.	Students demonstrate such knowledge in classroom discussion, a documented research paper, and in written responses to assigned works.
